Under the ITEC programmes, CMCs may avail the Civilian Training Programmes offered by various Indian institutes for the financial year 2017-18. The Ministry of External Affairs (MEA), GoI will bear the course fee, board and lodging and out-of-pocket allowance of the qualified nominees. The international air travel cost of participant should be borne by participant or his/her organization.
